

2023 Activity Report

This report provides an overview of SPLP activities conducted in 2023. The reporting is based on the Landscape Reporting Framework (LRF). This is the third year of SPLP report referencing to the LRF.

Forest and Natural Ecosystems

Phase 1 Mapping and understanding

- **395,943.34 ha** of peatland and **6,222 ha** of forest has been mapped since the start of the programme in 2020
- **53 mills** engaged with NDPE workshop

Phase 2 Commitment

- District governments of Siak and Pelalawan **committed to a no-deforestation and natural ecosystem management plan**
- **39 villages** committed to natural ecosystem management plan or conservation activities, e.g. through village regulation or social forestry
- **1 mill in Siak and 1 in Pelalawan** committed to be ISPO certified in 2024

Phase 3 Implementation

- Through partnership with WRI, Siak Pelalawan landscape monitoring system using Radar Alert for Detecting Deforestation (RADD) is established
- **9 Land Use Plans** developed covering protection for **9,826 Ha** riparian buffer, mangrove, and customary forest
- Enabling protection of **3,433 ha** village forest through paludiculture fishery in peat forest in collaboration with PT. Alam Siak Lestari
- Strengthening protection of **10 ha** forest village through village regulation issuance

Phase 4 Implementation

- Supporting national regulation on **106 ha** of forest recovery program (Strategi Jangka Benah) to address oil palm in forest area
- **1 mill** in Siak received their ISPO certification
- **31 villages** regulations from **23 villages** in Siak and Pelalawan regarding environment protection and monitoring

2025 Goals

Palm oil produced in and sourced from the districts is verified deforestation and peatland development free



Farmers & Communities

Phase 1 Mapping and understanding

- **543 smallholders** received STDB socialization since 2020
- **39 villages** in Siak and Pelalawan engaged in SPLP

Phase 2 Commitment

- **2,403 polygon data** collected and submitted for STDB application

Phase 3 Implementation

- **3,460 people** received training on sustainable land use and people, Good Agricultural Practice, and/or Best Management Practice for oil palm since 2020
- **65 trainers** trained under GAP Training of Trainers program
- **Supporting income generating activities:**
 - 2 compost house
 - 1 fishery (catfish)
 - 1 Silvofishery (Lokan/Polymesoda expansa)
 - 100 Ha Customary Forest (Kopung Sialang), producing honey and other non timber product
 - Corn farming, pineapple farming, muscovy duck (entok) farming

Phase 4 Progress & Delivery

- **183 smallholders** received STDB business registration entitling clean and clear farm from deforestation and land tenure conflict

2025 Goals

At least 50 high priority villages in which the livelihoods of palm oil farmers and their communities has improved



Multi-stakeholder Partnership

Phase 1 Mapping and understanding

- **51 government offices** at national, provincial, and district level engaged in **1 FGD** to map land conflicts in Siak and Pelalawan. The FGD was attended by **15 participants from Siak** (Office of Plantation, One Stop Investment and Integrated Services Service (DPMPTSP), Regional Secretariat - Land Administration, Provincial Agrarian Affairs and Spatial Planning/National Land Agency (ATR/BPN)), and **12 participants from Pelalawan** (Office of Plantation and Livestock, DPMPTSP, and Provincial Agrarian Affairs and Spatial Planning/National Land Agency (ATR/BPN))

- **1 training** on conflict resolution for mediators in Siak and Pelalawan in Nov 2023 attended by **10 participants from Pelalawan** (2 people from Governance and Partnership, 4 people from Office of Plantation and Livestock, 2 people from DPMPTSP, and 2 people from ATR/BPN) and **10 participants from Siak** (Regional Secretariat - Land Administration, Office of Plantation, DPMPTSP, ATR/BPN).
- **1 stakeholder matrix and power mapping produced**

Phase 2

Commitment

- The government of Pelalawan has signed **Memorandum of Understanding (MoU) No. PLLW.MOU/050/TAPEM-KS/2022/11 supporting the implementation of sustainable palm oil production in Pelalawan.**
- SPLP and the government of Siak has signed **Memorandum of Understanding (MoU) No. 03/HK/Mou/2020** about collaboration **to achieve Green Siak Commitment** (extended with MoU No. 9/HK/MoU/VII/2022 about supporting the implementation of Green Siak

Phase 3

Implementation

- Siak Secretariat consisting of **11 district departments, 1 CSO platform** (Sedagho Siak), and **1 Coalition of Private Sectors** for Green Siak (Koalisi Privat Sektor untuk Siak Hijau/KPSSH) is operational with joint operational support from SPLP, Sedagho Siak, and KPSSH
- Joint financial support on Green Siak Secretariat development and Pelalawan Regional Implementation Team (Tim Pelaksana Daerah/TPD) Secretariat supporting infrastructure of Regional Implementation Team of District Action Plan for Sustainable Palm Oil (TPD RAD KSB): chairs, set of computer, and projector
- **4 meetings** (quarterly) on development District Action Plan on Sustainable Palm Oil (Rencana Aksi Daerah Kelapa Sawit Berkelanjutan/RAD KSB) Siak coordinated by Green Siak Secretariat, **4 (quarterly) meetings** Siak DAP SPO meetings, public consultation for the issuance of PERBUP RAD KSB Siak 2022-2024, **4 (quarterly) meetings** of DAP SPO Pelalawan
- **Two regulations** on FFB partnership in Pelalawan and Mangrove protection in Riau (Pergub) are ongoing process
- **1 meeting** to showcase and monitor development partners' contributions to DAP SPO in Siak and Pelalawan attended by 45 participants (government, CSOs, companies, and partners)

Phase 4

Progress & Delivery

- **Siak Bupati Decree No. 106/2023 on DAP SPO** in Siak has been enacted.
- **Issuance of Siak Bupati Decree No.718/HK/KPTS/2023** for stipulating Implementing Team of District Action Plan for Sustainable Palm Oil

2025 Goals

Functioning MSP platforms are in place that include the local government and provide a clear governance and transparent reporting on sustainable palm oil production in the districts



Social Dialogue

Phase 1 Mapping and understanding. In 2022:

- Conducted the Collective Bargaining Agreement (CBA) benchmarking of **19 palm oil companies** using **51 indicators** developed by CNV. On average companies satisfied **37 out of 51 indicators**
- Conducted a research on Accessibility of Casual Daily Workers to Union Protection to assess casual daily workers' situation & challenges
- Roles and importance of Bipartite Institutions and gender committee in promoting social dialogue at the company level disseminated to RSPO's and POCG members

Phase 2 Commitment

- **3 palm-oil companies in Siak and 1 palm-oil company in Pelalawan** agreed to create gender committee workplan in 2024
- **3 companies** committed to form bipartite institution in 2024
- Office of Manpower, Office of Women and Child Protection, and Office of Plantation in Siak Pelalawan committed to form a team and provide technical assistance on bipartite agreement and gender committee to palm oil companies

Phase 3 Implementation

- **Bipartite Institution**
 - **6 palm-oil companies** in Siak and **5 palm oil companies** in Pelalawan received technical assistance on bipartite institution formation and improvement
- **Gender Committee**
 - **9 palm-oil companies** in Siak and Pelalawan participated in gender-based violence workshop and received technical assistances
- **Collective Bargaining Agreement**
 - **11 palm-oil companies** from management and union workers received CBA Training
 - **34 workers representatives** received training on union capacity development

Phase 4 Progress & Delivery

- **4 palm-oil companies in Siak and 4 palm-oil companies in Pelalawan** have gradually improved their Bipartite institution's structure
- **8 gender commi ee in palm-oil companies** in Siak and Pelalawan have been formed or reactivated
- **10 companies in Siak and 8 companies in Pelalawan** has formed and registered bipartite institution since 2020
